The Society for the Conservation of Nature of Liberia (SCNL) under the LEH GO GREEN Project. is seeking to hire a qualified and competent Agricultural Firm specialized in Cocoa Farming within Liberia, to supply 210,000 cocoa seedlings.

Targeted Counties: **Grand Gedeh and River Gee.**

Targeted Communities: **12 Communities in Grand Gedeh and 3 Communities in River Gee.**

1. Background

Protected areas (PAs) represent a key global strategy in biodiversity conservation. The implementation of sustainable livelihood activities that provide an alternative livelihood which is critical for achieving biodiversity and conservation objectives.

The project aims to promote responsible, productive, and sustainable management of forest resources through local communities, enabling them to meet their needs while stimulating community-driven conservation and livelihood development. The project will develop and strengthen the capacity of targeted farmers in forest-dependent communities. The project will develop 500ha of degraded farmland with cocoa. SCNL is executing this component of the project in collaboration with the FDA.

2. Objective of the Consultant

The Consultant will be responsible for the following

- Raise and supply 210,000 cocoa seedlings for 255 project beneficiaries.
- In consultation with SCNL, distribute mature cocoa seedlings to selected beneficiaries in the fifteen (15) project communities in Southeast Liberia.

3. Expected Requirements for the Consultant:

- Must have experience establishing a cocoa farm.
- Should be able to work in hard-to-reach project-based communities.
- Should have a good working relationship with the community.
- Should have an up-to-date Business Registration License and tax clearance to operate in Liberia.
